JOHN FOSTER DULLES, who may inherit Dean Acheson's tough job if Eisenhower wins the November election, made a speech on foreign policy tois week. Two points in the speech merit further discussion in the

The first was Dulles theory that Soviet-communism can "be disintegrated from within" by "passive resistance, slowdowns and non-co-peration". The truth is that primary emphasis on the defense of Europe was dictated by a set of hard facts that no amount of wishful thinking could evade. Some of them:

The West needed to keep Europe's great natural resources, notably coal and iron, out of Russia's hands.

2. The West needed Europe's vast reservoir of skilled labor and its extensively-

voir of skilled labor and its extensive, developed industries.

3. Because of geographic proximity, the loss of Europe would be a grave immediate threat to U. S. security.

4. Our hasty poster- demobilization left Russia with a vast military superiority, Because the ravages of World War II had left a military and seconomic vacuum in Europe, Russian power was a greater threat there.

But he surely knows that the first requirement of a free people is the desire for liberty. The peoples of Western Europe have known Leberty. Shady Financial Deals

McCARTHY'S tragled personal finances came to light including a \$72,000 loan by the Appleton State Bank which was secured, at one point, by a \$20,000 note signed by a widely known Washington sugar lobbyist.
