## SENATORS TO MONITOR SPY PROBES

Investigations Not Stopped By Ike's Hope Need To End

WASHINGTON (AP)—Senators investigating the Harry Dexter White case called a temporary halt today but gave no sign of abandoning their efforts because of President Eisenhower's suggestion that the need for such inquiries may soon be ended.

Sen. Jenner (R-Ind.) said he did not know where or how far the inquiry by the internal security subcommittee he heads would lead. The group's next session was set for Monday afternoon, but there was no announcement whether witnesses would be heard then.

Jenner told newsmen that "for the first time we have been able to show" that FBI reports on suspected individuals "reached the hands of top officials," and he added it was impossible to say now what developments might follow.

**HOPE EXCHANGED**  
Some Republicans and most Democrats seconded Eisenhower's hope, expressed at a news conference yesterday, that security findings may so completely solve the problem of alleged spies that the government that the issue will be forgotten by next year's congressional campaign.

Eisenhower said he was not suggesting current congressional probes be called off.

The President declined to comment directly on the case of White, who Atty. Gen. Brownell says was promoted in 1946 by former President Truman in the face of FBI reports which, Brownell asserted, tagged White as a spy.

**WHILE SENATE STEPPING OUT**  
While Jenner's subcommittee planned to go ahead with its hearings, the only ones in a congressional group thus far in the White case, the House Un-American Activities Committee showed signs of stepping out of the case.

Rep. Clegg (R-Mich.) announced to Lansing, Mich., yesterday that he saw no need now for a subcommittee to take testimony from Gov. James E. Byrne and Sen. William Jenner, who was Truman's secretary of state at the time of White's promotion. Clegg said he named to the subcommittee.

Eisenhower's remarks may have the effect of applying the brakes to the cabinet members' efforts in furthering the in the communist-infiltration field.

It was plainly evident that Republicans in Congress and elsewhere intended to keep the rolling to election time next November.

**MEANTIME TO SPEAK**  
Sen. McCarthy (R-Wis.) prepared a radio-televised report Monday night to Truman's indictment of "Communism."

## Reds Ask Neutral Parley Observers

PANMUNJON (AP)—The Communists said today they want neutral observers seated at the Korean peace conference only as observers. U.S. envoy Arthur Dean said the proposal "could offer a very fruitful basis for further negotiations."

Dean indicated the North Korean and Chinese diplomats have made a "preliminary concession" and now appear to be awaiting further instructions.

There were growing indications that a compromise may be reached on the thorny issue of inviting neutrals to the peace conference—the biggest issue to be settled at the preliminary peace talks here.

There is spokesman for the U.S. United Nations and South Korea, all of which have voiced opposition to neutral participation in the peace conference.

But the U.S. envoy noted that these nations assumed the Reds wanted neutrals to have full parol participation in the peace conference.

Dean already has said the United States would be willing to recommend inviting neutrals after a Korean settlement is reached or if the peace talks bog down.

## Penalty Suggested In Jury's Verdict

KANSAS CITY—(AP)—The kidnap killers of little Bobby Greenlease were sentenced today to die, Dec. 18 for their crime.

U. S. District Judge Albert L. Reeves passed the death sentence on Carl Austin Hall, 34, and Mrs. Bonnie Brown Heady, 41, within 15 minutes after a jury of 12 men recommended that they pay the supreme penalty for their confessed crime.

Mrs. Heady, the pudgy faced alcoholic, stood at the right of Hall, a slender playboy, when the judge pronounced the sentence.

Judge Reeves asked if they had anything to say.

Hall said clearly "No, sir."

Mrs. Heady shook her head in the negative.

Then Judge Reeves said solemnly: "I accept the recommendations of the jury. It is my duty to accept and adopt the recommendations of the jury."

Mrs. Heady had anything to say, Judge Reeves said it would be the judgment and sentence of the court that they be executed in the gas chamber at Jefferson City on Dec. 18—just one week before Christmas.

**READS IT TWICE**  
He read the sentence twice—once for Hall, then in the same words for Mrs. Heady.

The kidnapers' faces did not change expression. Both apparently were resigned to fate any way.

Robert C. Greenlease, multi-millionaire father of little Bobby who paid the kidnapers \$500,000 for their release, was not in the courtroom.

He said he did not know whether he would witness the execution of the killers.

As he left the courtroom, Greenlease commented of the sentence: "I am glad for them but it is the best the law provides."

He took the jury of 12 men out of the courtroom and gave Judge Reeves authority to send the pair to the gas chamber.

The judge asked the jury if the two were cold blooded murderers and there were no mitigating circumstances for their crime. The case was turned over to the jury at 10:45 a. m. (CST).

**INSTRUCTIONS SHORT**  
The judge's instructions were brief but clear as he carefully reviewed the case, point by point.

Judge Reeves made it clear that the jury was to impose the penalty; that was his function. But under provision of the Lindbergh kidnapping Act, he said, it was necessary that he be cloaked with this authority if the maximum punishment is to be levied against the couple.

The judge paid particular attention to Hall's efforts yesterday to plead insanity, but he said that anyone who committed such a crime was equally guilty regardless of mental state.
