HEARTENING SUPPORT IN FOREIGN AFFAIRS

SEN. LYNDON JOHNSON'S plea for foreign policy unity in the Senate yesterday had a familiar and welcome ring. Supporters of foreign policy were a reality in the days prior to World War II when the Good Neighbor Policy, the Four Freedoms, and the Atlantic Charter helped rally the free world against the threat of Nazism.

In these days, such accolades as Arthur Vandenberg of Michigan and Tom Connally of Texas, Warren Austin of Vermont and Robert Wagner of New York labored together to give the United States a firm, unified voice on world affairs. The present Republican Secretary of State, John Foster Dulles, served both the Roosevelt and Truman Administrations effectively.

In the face of a bitter attack on the Eisenhower \$1.5 billion foreign aid bill by Republican Sen. Langer of North Dakota, Senator Johnson rose yesterday to tell the Senate:

"The less partisanship we display at this critical time, the better it will be for the country. If we ever showed any on foreign policy, we need it now."

Johnson is Democratic minority leader in the Senate.

NO CASE WHATSOEVER AGAINST DOUGLAS

AT LEAST one credible thing can be said about Rep. William Wheeler of Georgia, who wanted to impeach Justice William Douglas, who delayed the death of the Rosenberg. The Congressman had the candor to acknowledge that some of his charges were "in error" and "hearsy."

Beyond that, of course, they were without substance, as members of the House Judiciary Committee who heard them yesterday concluded. And the House's attempt to tie the Justice up as a correspondent in a divorce case—was dastardly as well as unfounded.

Well, maybe Georgians must be granted special leniency when they rally against the Supreme Court. It was, after all, a Georgia case which caused President Truman to sign the McCarran-Johnson Internal Security Act. It was his decision—now let him enforce it. Georgians and Jackson were angered by the court's reversal of a murder conviction against a rebellious half-breed, name of Corn Tassel, who was hanged despite the Court.

Impeachment proceedings have been brought against only one Supreme Court Justice, Samuel Chase, at the behest of President Thomas Jefferson. Jefferson fought about his usual regard for free speech and got a Congressman to institute impeachment proceedings after Chase denounced some of the President's pet schemes and said his regime would drive the country into a "mobocracy."

But the move fell flat on its face. The Senate, after hearing the charges, acquitted Chase. Whereupon Jefferson remarked ruefully: "Such a farce should never be tried again."

So long as the state holds true today, certainly his statement holds true today, so certainly as the case against a Justice is non-existent as was Wheeler's against Douglas.

ON BASKETBALL AND THE COLISEUM

IF LOGIC and reason are given any consideration in the proceedings, Charlotte should be given the considerable site for future Southern conference basketball tournaments.

When the 10,000-seat Coliseum is completed some two years hence, the Queen City will hold out many advantages to the colleges in the conference—a large population, a central coliseum in the region, central geographical location, and neutrality.

In sending an advance invitation to the conference at its meeting last week, the Charlotte auditorium-coliseum commission was making good that the Queen City will stand as a neutral.

While it is on the subject, the commission should be giving thought now to lining up some top basketball games for the 1955-56 season. Duke, Carolina, State and Wake Forest, for example, should be persuaded to play at least one of their major games at Davidson can be counted on to book several of its top opponents. And Belmont Abbey, which is just beginning big-time basketball, will doubtless find the Charlotte coliseum a valuable adjunct to its program.

Since collegiate schedules are arranged months and even years in advance, the coliseum commission should begin now to work with sportswriters, alumni clubs and other interested groups and individuals to lay the groundwork for a full assortment of sports activities.

Frequent bookings will not only help the coliseum to pay its way, but will also satisfy the need of the community for better recreation. Both factors should be of interest to the new \$4 million enterprise.

A QUESTION

READING Arthur Krock's piece in the Sunday New York Times, we were reminded of a question that has been bothering me a long time.

Krock, recalled Secretary of State Acheson's 1950 speech in which he traced a geographical line around areas he said were essential to our security and that we would defend by force, if necessary.

Korea was excluded from that area. After the North Koreans invaded the Republic of South Korea, Acheson critics charged that the Secretary had "tipped off" the enemy as to our intentions. Krock describes the speech as a "classic diplomatic error of omission" and asks the details of "policy."

This is what bothers us. If the Acheson State Department was as thoroughly honey-combed with Soviet agents as his critics charged, wouldn't Moscow have known about the policy anyway, without any speech?

CURRENT HISTORY, A LA MCCARTHY

ONE characteristic of Senator McCarthy's technique has been the flagrant occasion, followed by more flagrant occasions designed to make the public and press forget to check previous charges. Now a new tactic has been added, and brought to light, thanks to the diligence of Washington Post reporter Murray Marder. How's what happened.

Donald Creed appeared before McCarthy's Government Operations Committee. He told of gross waste in the Voice of America, how a mobile recording unit ordered by the president cost \$28,000, that there were required a \$30,000 to \$35,000 adjustment to make it work.

This story got the big play, the headlines, started heads shaking about the Voice of America. Senator McCarthy went on to make new charges in other fields.

Marder stayed with the Creed accusation. He got his hands on an official record of Creed's testimony. In it the figures had been changed. The original cost of the unit was \$41,329.22, the adjustment cost only \$300. Creed had reduced his costs to conform with the facts.

But, had it not been for Marder's persistence, the original charge would have stood. The McCarthy committee didn't say "We were wrong." It didn't send corrective statements to the newspapers that had carried the sensational charges. The committee simply reversed the record in an attempt to protect itself in case someone attempted to check, but to the original impression of gross waste stand.
