

## Like To Tell Country U. S. Views On Israel

### Radio-TV Speech Planned

WASHINGTON (AP)—President Eisenhower discussed the grave middle east situation and the sanctions-on-Israel question with congressional leaders today, and decided to go on the air tonight with a report to the American people.

The White House said time was being asked on all major TV and radio networks. The hour was to be announced later.

A score of congressional leaders, both Democrats and Republicans, talked with Eisenhower, Secretary of State Dulles, and U. N. ambassador Henry Cabot Lodge Jr., for two hours and 20 minutes.

The lawmakers came away grave and with some apparent differences of views as to just what conclusions could be drawn from the meeting.

#### SUPPORT LIKELY

One of the Democrats, Sen. Jennings of Missouri, said his impression from hearing Eisenhower was that the administration is prepared to support the United Nations if the U. N. imposes economic sanctions on Israel.

The issue of sanctions has arisen because of Israel's refusal to withdraw its troops from the Gaza Strip and the Gulf of Aqaba area as demanded by the U. N. But Sen. Knowland of California, the Republican leader, told reporters no decision about possible support of sanctions had been "made."

Democratic Leader Johnson of Texas, asked whether he thought the administration would support sanctions, replied:

"The administration is well advertised as being able to speak ably, fluently and abundantly for its position."

Asked then whether the congressional leaders and the White House would stand in closer together, Johnson replied "the meeting was constructive and helpful."

As Secretary Dulles hurried out through a side entrance of the White House, reporters asked him "Will the United States support sanctions against Israel?"

"I expect there will be some thing about that later on in the afternoon from the President," Dulles replied.

Dulles said there had been "a very full exchange of views" during the conference but no "unanimity" of views. He would not say whether a "conclusion" was reached.

## Grand Jury Indicts Two Men For Dynamiting In Alabama

MONTGOMERY, Ala. (AP)—Two white men, one of whom city detectives say was photographed wearing Ku Klux Klan regalia, were free under bond today on charges of dynamiting the home of a Negro integration leader.

James D. York and Henry Alexander surrendered to Sheriff M. S. Butler, yesterday after the grand jury had indicted them in the bombing.

Detectives Jack Shocks and T. J. Ward said York, a road scraper operator for the city, was in a picture of a group of unmasked men in Klan robes and hoods walking on city streets shortly before a KKK rally in November.

They also were charged with bombing public buildings. Two other white men were arrested Sunday on similar indictments. Raymond C. Britt Jr. and Sonny Kyle Livingston Jr. are scheduled for trial Feb. 28 on charges of bombing two Negro churches and a Negro taxicab stand.

The police chief said "statements of some of the accused themselves" supported his charge concerning the Klan. Neither York or his attorney would comment on the picture.

### Low Scale Cited

Love Bill Calls For \$1 Minimum Wage

Mecklenburg Rep. Jack Love will introduce a \$1 minimum wage bill in the General Assembly today.

The bill will call for a \$1 statewide minimum wage to cover all labor with the exception of agriculture, domestic, commission salesmen and those customarily working for gratuities and tips.

Yesterday Love introduced a bill calling for a 15 per cent pay increase for state employees. Earlier he had put a bill in the hopper for a 20 per cent pay increase for teachers.

UNOFFICIAL ENDORSEMENT  
The measure, but not the amount, received an unofficial endorsement by Gov. Luther H. Hodges in his biennial message of Feb. 11 and further confirmation by a Hodges statement Sunday.

Gov. Hodges told the General Assembly, "In the state's program to raise its per capita income, we should have a minimum wage. One of the essential ingredients of prosperity is widespread purchasing power in the hands of the people."

BEATEN IN 1955  
A minimum wage bill was defeated in the 1955 General Assembly. The federal minimum wage act calls for a \$1 minimum.

Rep. Love said the bill covers "all people generally employed except agricultural, domestic servants, outside salesmen on commission and others to be determined by the Commissioner of Labor, and customarily receiving tips and gratuities in addition to wages."

"It is conceived," he said, "that all included are employees whose total number of employees do not exceed two persons."

## Teachers Ask Court To Throw Out Injunction

CONCORD, N. H.—The Manchester Teachers Guild today asked the New Hampshire Supreme Court to throw out a lower court injunction which halted an unprecedented ten-day teacher strike in the state's largest city.

Courts "should not interfere in labor disputes without the clearest showing of imminent danger to the community," the Guild said in a brief filed by attorneys Kenneth P. Grant and Jack B. Middleton.

"There is nothing inherently illegal about a strike of public employees for higher wages," said the brief, whose membership includes 322 of Manchester's 355 public school teachers.

The Guild also contended that a temporary injunction issued by Superior Court Justice Robert F. Griffith violated the "due process" clause of the 14th amendment of the Federal Constitution.

In the city's brief, City Solicitor J. Francis Roche contended "teachers are public employees and do not have the right to strike."

Both public policy and common law deny public employees the right to strike against government.

"Such a strike is illegal in its inception," Roche said, "and cannot be considered reasonable conduct on the part of teachers. The temporary injunction was properly granted."

The high court scheduled oral arguments in the case today.

A decision is not expected for several days.

All 365 Manchester teachers struck away from their jobs Feb. 4 in the climax to a months-long wage controversy with city officials.

The city closed its 24 public schools and 8,217 students were given an unexpected two-day "vacation" which they were forced to "make up" Monday and Tuesday of this week—normally a mid-winter vacation period.

## C Of C Denies U. S. Classroom Shortage Report

WASHINGTON (AP)—The U. S. Chamber of Commerce said today there is no critical national shortage of classrooms, and that it regards federal aid for school construction "unwise and unnecessary."

The chamber position was presented to a House education subcommittee by Thomas A. Ballantine of Louisville, Ky., chairman of the chamber of commerce committee on education.

He said in prepared testimony: "It is the consensus of business in this country that the states and their communities are responsible for, and able to finance the development of the school systems required by their citizens."

Ballantine added that federal help "would lead inevitably to the transformation of public education from a state and local function to one increasingly directed by the federal government."

The Kentucky businessman added that "no critical national shortage in classrooms has been or can be demonstrated to exist."

1-YEAR PLAN  
The House committee has before it an administration bill which would provide for \$1,200,000,000 in federal aid for school construction over the next four years. Other proposals also are under committee consideration.

Ballantine said a report by the U. S. Office of Education states 65,000 new classrooms were built in the year ending last fall. About 49,000 of these would have taken care of the report's estimated enrollment increase of one million and its estimated figure of 14,000 for abandoned classrooms, Ballantine said.

That, he added, leaves a surplus of 14,000 classrooms for "pupils in excess of enrollment capacity."
