**Pilot Tells Of Jet Brush**

**Hagerty Parries Questions**  
WASHINGTON (AP) — Two Republican senators demanded today that Sherman Adams, top presidential aide, give a full explanation of expensive favors he received from Boston industrialist Bernard Goldfine.

The demands came from Sens. Barry Goldwater (Ariz.) and Charles E. Potter (Mich.) who suggested Adams should leave the White House unless he offers a complete accounting.

At the same time a Democratic senator, Joseph S. Clark (Pa.) told the senate that Adams "acted in extremely bad taste."

The White House kept silent in the face of the congressional criticism.

Presidential Press Secretary James C. Hagerty declined to discuss Potter's assertion that Adams "has lost his usefulness to the administration" unless he can explain more fully.

Hagerty replied "no comment" to repeated inquiries by reporters. He referred them to his statement yesterday that the issue was whether Goldfine received favored treatment from government agencies as a result of gifts to Adams.

Both Adams and Hagerty have denied that Goldfine got any preferred treatment in dealings with government agencies.

**Exam Ordered For SC Man**  
BENNETTSVILLE, S. C. (AP) — murder warrant and a mental examination were authorized almost simultaneously yesterday for Henry A. Rogers, 67, veteran Marlboro County clerk of court.

Rogers, held in the slaying of State Sen. Paul A. Wallace, was transferred from the State Penitentiary at Columbia to the State Mental Hospital there.

The mental exam was ordered by Fourth Circuit Judge J. Woodrow Lewis of Darlington. State law requires that a report of the findings be made to him within 30 days on the mental condition of Rogers.

Accounts of the election-night slaying were given yesterday on an inquest. The coroner's jury recommended that Rogers be held for grand jury action.

Witnesses who were in the Marlboro sheriff's office when the 57-year-old Wallace was fatally wounded there last Tuesday night said this account of the shooting.

Rogers stalked into the office clerk, without speaking, opened fire at Wallace with a .32 caliber revolver. The state senator got to his feet after the first shot and pleaded either "don't" or "no."

**Bonds Were Reduced Press Disrupted**  
**Boyd 'Bargain Day'**

A transcript of proceedings in Judge Basil M. Boyd's city recorder's court on June 4 shows the judge in the process of making substantial reductions in forfeited bonds when he was interrupted by a Charlotte News reporter.

The News had been told this was the case but it had not been definitely established until a copy of the transcript was secured this morning.

At the time the News reporter walked into his court the morning of June 4, the transcript shows, Judge Boyd had considered eight of the cases listed in an auditor's report made public this week. Seven of the eight were cases in which bonds had been ordered forfeited, but they had never been paid.

Judge Boyd and Solicitor George Miller had summoned local professional bondsmen for a conference on the subject of the unpaid bonds. Attorney Allen Bailey was in court and presumably spoke for bondsmen S.

When the reporter entered his courtroom, the judge had actually ruled on five of the cases, with bonds totaling \$650. The judge took the cases one by one and ordered reductions in the various bonds totaling \$425.

**NOT SIGNED**  
Judge Boyd has not signed the orders making these bonds absolute.

Here is the text of the transcript:

**SOLICITOR:**  
Judge, In Case No. 2129, on the 30th of March, 1956, bond was forfeited in the amount of \$300.00. I would like to have this bond made absolute.

"MR. ALLEN BAILEY (Representing the bondsmen):  
I wish you would permit me to make a statement with reference to all of these bonds, which I believe would appear in many of these cases, and in this particular one, the defendant was in court on one occasion. Prayer for Judgment was continued a bit and run case. Prayer for Judgment being continued for the man to pay certain damages and this was done when the sentence was made. The man, Adams, came back to court. I know, and the bondsmen know that a bond remains in the court until the case is finally disposed of, but I believe in cases such as these where a defendant has appeared in court for trial and prayer for judgment has been continued for him for the convenience of the defendant that the bondsmen should be shown some consideration if he does not reappear as he is supposed to. It is the time

**TO CONFER MONDAY**  
Chief Littlejohn said he expects to confer with Solicitor Grady Stott and Judge Zeb V. Nettles Monday concerning his appearance before the grand jury.

The civil service board will hear the dismissal recommendations on Capt. Henkel and L. White June 22.

The 10 people subpoenaed by the Civil Service Board at the chief's request are H. E. Offin and Charles W. O'Daniel, accountants for the George G. Scott Co., which audited records of the city's office for 4 years.

Mrs. Mildred Pierson, clerk in the Traffic Division; Desk Sgt. H. L. Robinson; Traffic Patrolman J. B. Norman; professional bondsmen J. F. Jimi; Poplin; and attorneys Allen A. Bailey and John G. Plumides.

**SPECIFIC CASE**  
It was revealed that Mr. Plumides was subpoenaed for his connection with a specific case, that of a New Jersey Poplin; and was arrested in Charlotte Jan. 12.

In that case the defendant was freed on \$500 bond signed by J. H. Bramley. As the charge was not considered a felony in his case.

At the present time there are no forfeited and unpaid bonds out in Recorder's Court.

This is in contrast with the over \$30,000 in overdue bonds that is presently outstanding in City Recorder's Court.

The county court has \$9,865 outstanding in appearance bonds signed by professional bondsmen at the present time, but none of this amount falls in the overdue and unpaid category.

The cases for these defendants under bond have not been called as yet.

However, Sgt. Hinson noted that only \$1,250 of this amount has been signed by professional bondsmen since the total of unpaid bonds in city court was made public.

**NEARLY HALF**  
Bondsmen Leo Reynolds has signed nearly half of the bonds that are now out in county court.
