New Tactic Gives Jap Defenders Tough Task

Fires Get Start While Japs Hide

GUAM — (AP) — In a marked departure from recent fire raids, 150 Superforts blasted war industries and the arsenal in Osaka, the Orient's leading industrial city, with high explosives and incendiaries today in their fourth large scale raid on Japan within a month.

The B-29s hit this morning at Tokyo Radio admitted 200,000 more Japanese have been driven from their homes by American air attacks and will be moved to farms to help raise Japan's meager food supply.

THREE-HOUR ATTACK

The bombers struck for three hours through heavy overcast. Hosts resisted but were not organized. A joint Japanese Army-Navy announcement admitted fires were started in the northern and northern industrial sections. The enemy said flames were "steadily being brought under control."

Tokyo did not disclose the extent of high explosives aimed at the concrete and steel buildings of the huge Osaka arsenal, where much of Japan's medium artillery and small arms are produced.

But enemy broadcasters did complain that this series of raids had caused a large number of civilian air defense units coming to air raid shelters while other B-29s showered incendiaries on the factory district. The blazes there started before the B-29s left and out of their bomb shelters.

SUICIDE BASES HIT

Almost simultaneously with the Superfort blow Japanese dispatches said 40 Army and Navy fighters from Okinawa swept over Kyushu and launched suicide plane attacks. In the second raid in two days, Tokyo Radio said the fighters appeared to be primarily kamikaze bombers, attacking propaganda leaflets over the city of Kaseiham.

Enemy radio reports indicated that about 100 Superforts had dropped high explosive bombs on Osaka, while the greater part of the force concentrated on getting new fires. While the total bomb weight was not announced, the attack was said to have caused 3,000 tons of incendiaries on steel fire raids.

For War Criminals

Jackson Urges Sure Punishment

WASHINGTON — (AP) — The Chief American prosecutor of Axis war criminals today urged sure punishment for the guilty, and declared against any dilatory tactics in trial procedure.

The trials, said Supreme Court Justice Robert H. Jackson, must not be regarded in the same light as trials under the American system, where defense is a matter of constitutional right.

DILATORY TACTICS OUT

"Fair hearing for the accused, of course, required to make sure we punish only the right men and for the right reasons," he said. But the procedure of these hearings may properly be characterized as dilatory tactics in our ordinary criminal trials.

Failure to try these accused, he stated, "would mock the dead and make chairs of the living." Justice Jackson, chief of the prosecution of the United States in the prosecution of Axis war criminals, told the Supreme Court today.

Quizzed On Yalta Talk

LONDON — Prime Minister Churchill told Commons today that the Big Three made no secret agreement at Yalta that had already been made public, but indicated that the discussions covered a wider field than the decision officially announced.

Lawmakers asked specifically why differences had arisen over the production of the Polish secret agreement—an issue many believed settled at Yalta.

"There were no secret agreements entered into at all," except the agreement to give Russia three per cent of Poland's territory, asserted Parliament. He then added significantly:

"The conversations of course proceeded in a very intimate way, but I am not prepared to say that everything discussed at Yalta could be made the subject of a verbatim report."

Russia Calls

For New Big Five Huddle
