Little Terry Arrives Here Ill From Rough Plane Ride

Little Terry Taylor came home to Charlotte this afternoon but she was feeling too ill to be excited by the large crowd of people who greeted her at Municipal Airport.

Dr. and Mrs. Andrew Taylor brought their daughter back from Washington on an Eastern Air Lines plane which landed at 1 P. M. after a rough flight in windy weather.

Tonda walked up the steps to the plane when she saw her mother and said, "Hi, Mommy."

Terry didn't feel like saying anything. Her tummy was doing something. "Hi, Mommy," she said.

CLUTCHES COMIC BOOK
She clutched a comic book which she had been trying to look at to take her mind off the rough flying.

"Terry tells a stranger story about what happened to the maid," said Dr. Taylor. "She might not tell strangers, but she has been telling me about it."

"There wasn't any soldier involved," Terry and the maid told. Attempts to get Terry to say anything were unsuccessful. She didn't even smile when her sister Tonda was asked.

"Terry, I heard you on the radio, and all you would say was 'bye, bye, bye.'"

The child wouldn't even say that today. The crowd of people who had come to the airport for a glimpse of Terry respectfully stayed at the Administration Building while news-papers men talked to the Taylor family at the plane.

"I don't know yet just what our plans will be for the next few days," said Dr. Taylor. "The first thing is to get Terry and her mother home so they can recover some."

A neighbor had brought the Taylors' youngest child, Drew, to the airport. Mrs. Taylor held Drew in her arms while photographers took pictures, but didn't feel like carrying him.

FBI Says Her Name Is Brozek

An extradition hearing for Loretta Frances Brozek, the nursemaid known here as Rosemary Johnson, who left Charlotte Tuesday with Terry Taylor, is scheduled to be held in Washington Monday and decision on whether she will be tried in Federal or State courts will be reached later.

This announcement was made today by Police Chief Walter F. Anderson, who earlier in the day had announced that the nineteen-year-old Nebraska farm girl would be tried in Federal Court.

Later information reached local authorities that papers demanding an extradition hearing had been filed by a Washington attorney and that the hearing had been postponed until Monday.

Then Chief Anderson announced that Federal authorities, represented by the FBI, would continue in their unofficial connection with the case and that no move would be made toward turning the case over to the office of District Attorney D. E. Henderson until after the hearing.

The hearing ends in decision to permit the return of the youthful nurse to North Carolina, she will be brought back by the FBI. Capt. Frank N. Littlejohn of the Charlotte Police Department was a Federal agent.

Takes First Step Toward Calling Coal Diggers Out

Wage Talk Move Also Made

WASHINGTON — (AP) — John L. Lewis today took the first step toward calling his United Mine Workers out of the coal pits by filing a 30-day strike notice for some 400,000 soft coal miners.

At the same time, the UMW chief declared a dispute existed between the UMW and soft coal operators over wages, hours and other working conditions and invited the operators to a conference March 12 in Washington to reopen negotiations.

The strike notice did not affect the 70,000 hard coal miners in Pennsylvania, who are covered by a separate contract.

WILL KEEP WORKING
The soft coal miners, Lewis said, will continue to work for the next 30 days in compliance with the War Labor Disputes Act under which the strike notice was filed. The notice went to the National Labor Relations Board, Secretary of Labor Schwelb and the War Relocation Authority.

Manifesto To Spain Due

WASHINGTON — Britain, France and the United States pressed today for final agreement on a joint declaration encouraging Spaniards to overthrow Generalissimo Franco. But the question was: which Spaniards?

Diplomatic representatives of the three powers were intent on getting the proposed proclamation ready for public release this week, but had not yet agreed on the issue of what elements to address in the manifesto.
