What Will You Do, Charlotte?

IF CHARITY begins at home, many citizens of Charlotte have forgotten it. In the Community Chest campaign that was slated to end Tuesday night, residents of Charlotte failed in their obligation to their neighbor; contributions fell short of the necessary million dollars. Housewives check change out of sugar jars, while collar workers signed for pay roll deductions, industrial workers contribute, business leaders made special gifts, but the total was not enough money to support the Chest's 21 agencies for the next year. If the Chest's goal of \$307,308.87 is not reached by 1 o'clock tomorrow afternoon then those agencies will be terribly handicapped. In neglecting the Community Chest we have neglected our responsibility.

Why have we failed? Perhaps because we have not understood that the Community Chest goal is not merely a set of figures preceded by a dollar mark but food, clothing, shelter, medical care for children, for disabled, for those who cannot help themselves. Perhaps it is because we have not seen the tired women who carry crying babies into the Salvation Army's Emergency Home for Women—asking nothing for themselves, only food for their children. If we fall the Chest will fall these children.

There are many other Community Chest agencies just as urgent. Just as essential. If you have already given, give again if you can—because all that you can give is needed. If you have not given—give now.

Voting In Bond & Tax Elections

OF THE four constitutional amendments before North Carolina voters next Tuesday, none is more deserving of support than that which would change our system of holding special bond and tax elections. The present method for such elections is prescribed in Article VII, Section 7 of the North Carolina Constitution. It reads: "No County, City, town, or other municipal corporation shall contract any debt, pledge its faith or loan its credit, nor shall any tax be levied or collected by any officer or board except by a majority of votes actually cast, unless by a vote of the majority of the qualified voters therein."

The proposed amendment would strike out the words "by a majority of votes actually cast" and substitute this phrase: "Unless approved by a majority of those who shall vote thereon in any election held for such purpose."

There is a vast difference, much greater than casual examination of the amendment would indicate.

The North Carolina Constitution, and various rulings of the State Supreme Court, have afforded "the right" to the government to include such things as police and fire protection, water and sewage systems, schools, streets, and the like. But there are many functions of County and City Governments, such as providing libraries and recreational facilities for its people, which have been defined as "unnecessary" expenses of government by the Supreme Court and for which taxes are levied unless by a majority of the people in accordance with Article VII, Section 7. If Charlotte, for example, wishes to build a new civic auditorium, the City must first obtain permission of the State Legislature. It is the only section for that purpose. Then a date is set. Any voter wishing to participate in the election is required to go

to the polling place prior to the election and register in a special book. On election day, only those persons who have specially registered can cast a ballot.

Suppose an even 10,000 people register for the election. For the issue to carry, 5,001 favorable votes must be cast. A "majority of the qualified voters" according to Article VII, Section 7. It does not matter how many, or how few votes are actually cast against the proposal. The only thing that matters is the number of votes actually cast in favor of it.

This is the so-called "vote against majority" procedure which, in effect, makes it possible for a duly registered voter to vote "no" to a proposed amendment, and help defeat it, simply by staying away from the polls on election day; whereas, a voter who favors it, must register and then go back to the polls and cast his ballot. In other words, it is wrong and is contrary to the established traditions of the U. S. free election system. (Example: A person who favors a bond issue might be called out of town, or might become too ill to vote, yet the issue would be decided for the election county's vote against the issue.)

We saw it happen in Charlotte in 1946, when a good many proposals, some necessary and some "unnecessary," were voted on. The "necessary" ones passed, because the vote was not against registration; the "unnecessary" ones failed, despite overwhelming majorities of the votes actually cast.

We will have more democracy in North Carolina, and our cities and towns will be in a better position to furnish the services and facilities needed in this modern, industrial age, if we amend the Constitution on special elections and bring our Constitution up to date by adopting this amendment.

The First Flowering Of A Noble Dream

SUNDAY afternoon in the little Eastern Carolina town of Ahoskie citizens of the Roanoke-Chowan County and the Pamlico-Chowan County are proudly marking a significant milestone in North Carolina's slow march toward adequate medical care for all her people.

The Ahoskie hospital can claim two firsts:

(1) It is the first hospital completed under the North Carolina Medical Care Commission's building program.

(2) It is the first to receive funds from the recently passed Hill-Burton Federal Hospital Construction Act.

For North Carolina the hospital symbolizes the first tangible result of the widely heralded medical care commission plan. Actually, the Ahoskie institution was about 92 per cent subscribed to before application of either State or Federal funds. Four years, eight months ago, the citizens of Ahoskie, through a long and hard, but nobly furnished, with medical facilities) began their hospital fund-raising campaign. Their efforts netted all except eight per cent of the amount required is a tribute to their enthusiasm and perseverance.

But the 3,000 citizens who turned out for the dedication were informed by the program's principal speaker of the wider implications of the hospital's opening: "You can't improve the first of the noblest things," said Claude F. Gaddy of Raleigh, chairman of the Medical Care Commission's Hospital Advisory Council. "It is not going to serve just your area, but it is the beginning of a program for thousands. You are joining allegiance and hands with the people of the state and nation in greater medical care for our people."

The speaker was alluding to the fact that the Ahoskie hospital is one of eleven which the Medical Care Commission will help construct this year. (Others are to be in Belhaven, Scotland Neck, Troy, Laurinburg, Clinton, Lenoir, Star City, Roxboro, Albemarle and Lenoir.) The eleven will give the state 682 new hospital beds at a total cost of \$7,743,115.

Thus, as the four-story, fifty-bed, red-brick structure opened its doors in Ahoskie—a combined product of Federal, State and private funds—North Carolina was seeing the first fruit of a plan born in the minds of a group of the most earnest, who share four years ago by some shameful slights.

The Medical Care Commission grew out of a meeting of the trustees of the University of North Carolina on Jan. 31, 1944.

At that meeting Gov. J. M. Broughton offered a report from a committee of distinguished medical men and prominent North Carolina, they said, is the eleventh most populous state in the Union but she ranks 42nd in number of hospital beds per 1,000 population and 45th in number of beds per 1,000 population. They recommended:

(1) The expansion of the two-year medical school at the University of North Carolina into a standard four-year medical school with a central hospital of 600 beds or more; and

(2) A hospital and medical care program for the entire state with this noble objective as expressed by Governor Broughton: "The ultimate purpose of the program should be that no person in North Carolina shall lack adequate hospital care or medical treatment by reason of poverty or low income."

Soon after the university trustees endorsed the program, Governor Broughton appointed a 60-member Hospital and Medical Care Commission to study ways and means of executing it. The 1947 Legislature approved the Commission's recommendations, and now the Ahoskie hospital is a result of that chain of events.

This is the wider significance of the dedication ceremony at Ahoskie Sunday. It is the first of the noblest things that would continue North Carolina's finest humanitarian tradition.
