Bad Treatment of Prisoners Denied by U.N.

75 Americans Freed in Latest Exchange

By WILLIAM J. WAUGH PANUNION—A—The U. N. committee today bluntly denied Communist charges that prisoners had been brutally treated. It told the body the physical condition of repatriated POWs proved the accusation was a "distortion of the truth."

The denial was made at a meeting of the POW Repatriation Commission and answered Communist charges leveled last Friday.

Another 75 Americans were liberated here Wednesday while two ships prepared to sail for home with men freed earlier by the Reds.

Answers Refused By Mrs. Rothschild

By ED CREAGH WASHINGTON (U.S. News)—Mrs. Edward Rothschild refused today to say whether she has ever spied for the Communists or helped her husband do so.

The husband, a bookbinder in the Government Printing Office (GPO), was suspended from his post yesterday after he declined to tell Senate investigators whether he was a Communist or had stolen secret documents sent to the GPO for printing.

As did her husband, the slender, dark-haired Mrs. Rothschild told the investigations subcommittee headed by Sen. McCarthy (R-Wis) that to answer questions about espionage or Communist activity might tend to incriminate her.

McCarthy announced at today's session that he plans to open public hearings some time in the future on another matter—the alleged leaking of secret military information to a Washington newspaper correspondent.

Ike Calls For Action On Job Discrimination

Committee Sworn In As President Watches

By BELMAN MORIN NEW YORK (U.S. News)—President Eisenhower has called for an action committee to deal with the problem of discrimination in employment on government contracts.

Seven members of the Government Contract Committee took the oath in Eisenhower's presence in the Waldorf-Astoria Hotel today.

The President interrupted his Western vacation to fly here for a busy day of government activity, including the dedication of a 32-million-dollar federal housing project.

Regular traffic at La Guardia Airport was suspended for 10 minutes while the President's plane, Columbine, landed after an overnight flight from Denver.

Eisenhower drove directly to the Waldorf-Astoria and breakfasted with Lewis L. Strauss, chairman of the Atomic Energy Commission, and C. D. Jackson, the President's adviser on psychological warfare.

Explanation Of Red Proposals Awaited

UNITED NATIONS, N. Y. (U.S. News)—United Nations delegates waited for an explanation today of the Soviet Union's Korean political conference proposals from Russia's Andrei Vishinsky.

Lodge declared the resolution Vishinsky put before the U.N. Assembly was designed to let the Communists dominate the peace party. Other delegates reserved comment on the Russian proposal.

Vishinsky was expected to speak before the committee today.

The Soviet program called for a peace conference to be made up of 11 countries, including five "neutrals." This in direct contrast to American desire to limit the talks to nations whose troops fought in Korea.

Russia proposed these conference members: 1. Three U.N. members whose

troops fought on the U.N. side—the United States, Britain and France—and South Korea; 2. The two Communist belligerents—North Korea and Communist China;

Followers Invite Shah to Return

LONDON—(AP)—Teheran radio declared that royalists wrested away control of the Iranian government from Premier Mohammad Mossadegh today, sent him into flight, and summoned the Shah to return to his throne at once.

A proclamation was read repeatedly over the radio, monitored here, proclaiming Maj. Gen. Fazlollah Zahedi the new premier and promising Iranians a new eight-point program of social reform.

The latest cable from Donald B. Schwid, the Associated Press correspondent in Teheran, was filed at 1:10 P. M. Teheran time (5:10 A. EST) while the radio broadcast was at 7:28 A. M. Schwid's message said a royalist uprising in the army and police had fired and that there were pitched battles in the center of the city.

MANY TROOPS FIRED The first determined efforts of police and troops loyal to Shah Mohammed Reza Pahlavi to capture central police headquarters were at a "halt of shots," the dispatch said. "Hundreds of shots were fired over the heads of demonstrating mobs in Sepah Square."

"Pro-Shah mobs burned at least eight buildings in the center of the city before the demonstration crystallized into armed attacks by loyalist police and troops on key buildings at the foreign ministry."

U. S. Embassy reports to the State Department from Washington through the press that the Shah is still in the hands of "pro-Mossadegh forces"—meaning that resistance still remained alive.

A State Department spokesman said it was impossible yet to form a conclusion as to the outcome.

RED BUILDINGS BURNED One of the buildings reported burned in these diplomatic reports was the Sead Hotel, frequented by members of the Yehud (Communist) party, and a Russian shop in Teheran was reported attacked by mobs.

Dispatches filed earlier from Teheran this morning told of mob violence and police gunfire in the capital.

These accounts said the disorders were caused by police efforts to halt Nationalist supporters of Mossadegh and Communists from continuing frenzied demonstrations against the Shah.

State Will Pay Higher Interest

RALEIGH—(U.S. News)—The state opened bids on 14 1/2 million dollars in state installment contract bonds today, and a tabulation showed that the lowest interest rate offered on the securities was 2.8009 per cent.

The low bid was offered by a syndicate led by Halsey, Stuart and Co. of Raleigh and bid was 2.8009 per cent.

The low bid was substantially higher than the 1.94 per cent rate the state received when it made its last bond sale—the final 75-million-dollar batch of the 200-million-dollar secondary road bonds. That was in June of 1951, and interest rates in general are substantially higher than they were then.

The Council of State met after the tabulation of bids was completed and voted unanimously to accept the low bid.

A total of 30 companies were interested in the sale, Stuart syndicate.
