Ministerial Association Directs Resolution To Assembly—Backs Salvation Army Campaign.

Man Facing Trial For Killing In Very Ill

Charlotte, Feb. 8.—(UPI)—William T. McCord, scheduled to sit on an inferior court for the staying of his trial for the killing of his wife, died yesterday morning at the hospital where he had been held since December 28, in a local hospital critically ill of pneumonia.

While in jail waiting trial, he had been held incommunicado, which developed into pneumonia last night. He was removed to the hospital that morning. His case is the third trial date set for the physician who had been held since January 21, most recently called upon the court and who is expected to attend from this country.
